SUPPORTED COMMUNITY LIVING ASSISTS IN DESIGNING A SKILL-BASED TRAINING PROGRAM INTENDED TO ASSIST THE PARTICIPANT IN BECOMING MORE INDEPENDENT IN THEIR HOME AND COMMUNITY.
